

**REQUEST FOR PROPOSAL
FOR
Network Equipment – Wireless Lan Controllers**

The Kiel Area School District (KASD) is seeking Request for Proposal (RFP) for one Wireless LAN Controller (WLC). Vendors must be able to provide this service in compliance with Federal E-rate regulations, including having a valid SPIN number. Proposals from Vendors without a SPIN number will not be considered. All bids shall have pricing available until April 15th, 2018.

Scope of Work

Due to the complexity and interoperability of the proposed solution the district is seeking a single vendor to provide all products and services requested. We expect a complete turnkey solution and expect the awarded vendor to perform all duties for a fully functional system. The vendor will coordinate and manage the entire project and engage all necessary parties including but not limited to District Technology staff, building level administrator, Internet Service Providers and network equipment manufacturers. The vendor will coordinate a thorough site survey if necessary of each location prior to installation. The vendor will coordinate scheduling with consideration of impact on the instructional programs or existing services to include after normal school and work hours.

Vendor must install and configure all WLC's and management software. The vendor will configure all SSID's, security policies, and other items at the direction of KASD technical staff. The vendor must label all equipment and install in proper MDF or IDF at the direction of KASD technical staff.

Workmanship

All work shall be performed in a professional manner. Personnel from KASD may observe the work procedures and workmanship of the vendor, but such observation will not relieve the vendor from any responsibility of performance or constitute acceptance of the work performed. The vendor shall be required to maintain a clean and safe work environment. The vendor and his representatives shall follow all applicable school district regulations while on the KASD property, including the no smoking, no weapons, and drug free policies. No work shall interfere with school activities or environment unless the District Technology Coordinator gives permission. All vendor personnel shall be easily identified by the use of identification badges and lanyard issued by KASD. KASD reserves the right, with sole discretion, to refuse to allow any

representative of the vendor to service the contract in any manner. In this event, the vendor shall furnish another representative that is acceptable to KASD. Examples of reasons for refusing to allow a vendor representative to service the contract include, but are not limited to:

- o Use of profanity or abusive language around any school personnel or students.
- o Unclean or unkempt appearance.
- o Intoxication or obvious drug use.
- o Threatening behavior towards any school personnel or students

Price Quotations

Price quotations are to include the furnishing of all materials, equipment, maintenance and training manuals, tools, and the provision of all labor and services necessary or proper for the completion of the work

Equipment Specifications

The proposed solution will include one Wireless LAN Controller. The WLC will need to be equivalent to a Cisco 5520 WLC.

The proposed solution will include all necessary cables and components to connect the WLC to the necessary switch ports. The proposed WLC needs to be able to connect to 10Gb ports on our ex4600 switches.
